NOTICE IS GIVEN that we are applying to the Consistory Court of the diocese for permission to carry out the following:

Reordering entailing:

(1) Introduction of external glazed doors to south porch, removal of draught lobby, replacement of internal doors with glazed doors, modifications to floor levels, drylining to interior of porch, and introduction of lighting and emergency signage.

(2) Removal of fixings for all pews in the central two blocks in the nave to make them movable.

(3) Disposal of all pews from the south aisle (retaining one to demarcate area at west end) and carpeting the retained pew platform in blue carpet to match carpet at the east end of the aisle.

(4) Disposal of all black plastic chairs and introduction of c.32 new Howe 40/4 chairs with red upholstered seats.

(5) Introduction of portable servery unit on castors in parish room and removal of radiator closest to kitchen door.

#### **Directions to petitioner**
