NOTICE IS GIVEN that we are applying to the Consistory Court of the diocese for permission to carry out the following:

(1) Remove a diseased ash tree and coppice a sycamore and a lime tree on north side of the church; plant three fruit trees beside the path from steps in the southeast corner of churchyard; remove two existing tree stumps in north side of churchyard.

(2) Introduce benches along the south wall of the church (three along wall, one in Garden of Remembrance) and two along path from steps in the southeast corner, all to be affixed to existing stone flags or set on new flags; also to replace current benches in poor condition.

(3) Introduce a low post and chain-link fence around the edge of the Garden of Remembrance and provide an extension to the stone slab paving to create a path to the newly introduced bench.

(4) Repair light above entrance gate.

(5) Extend cobblestone edging along the south side of church to replace the cracked and broken tile finish in this area; refinishing of other path areas.
